OFFICE MEMORANDUM

Subject :- DEARNESS ALLOWANCE

The undersigned is directed to refer to this Department's O.M. No.F(PR)-15/97/Pt/508 dated 20.12.2005 and to say that the Governor of Meghalaya is pleased to decide that the Dearness Allowance payable to State Government employees shall be enhanced from the existing rate of 21% to 25% with effect from 1.1.2006.

2. These orders shall also apply to the members of the Work-charged Establishment and Casual Employees other than Bungalow Peons, holding posts in the scales of pay as admissible to the employees of corresponding categories under the regular establishments/services/posts.

3. The Dearness Allowance under these orders shall remain suspended if the pensioners/family pensioners are employed/re-employed under the State/Central Government or re-employed /employed/permanently absorbed in the State or Central Government, Company, Corporation, Undertaking or Autonomous Body. It shall, however, be revived after the spell of such re-employment/employment.

4. The payment on account of the Dearness Allowance shall be rounded off to the nearest rupee.

5. The payment on account of the Dearness Allowance sanctioned herein shall be debitible to the respective heads of accounts from which the employees draw their salary and the pensioners their pension.
